

True Blue Family Getaway Sweepstakes
Official Rules:

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

Eligibility: The True Blue Family Getaway Sweepstakes (the “Sweepstakes”) is open only to those at least 18 years of age or older or the age of majority in their state of residence, whichever is older, and a legal resident of the 50 United States or the District of Columbia at the time of entry. Entrant must, as of the time of entry, own a WiFi-enable digital device capable of taking photos and/or videos. The Sweepstakes is void where prohibited by law. Employees of WGN Continental Broadcasting Co. (“Sponsor”), Tribune Media Company, their parents, affiliates, and subsidiaries, and the prize supplier, advertising agencies, promotion agencies, and other entities involved with the development or administration of the Sweepstakes (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Sweepstakes. Agreement to Official Rules: By participating, the entrant agrees to be fully unconditionally bound by these Official Rules and represents and warrants that the entrant meets the eligibility requirements. In addition, entrant agrees to accept the decisions of Sponsor as final and binding as they relate to the conduct of this Sweepstakes.

Sweepstakes Period: Entries will be accepted online starting on Wednesday, May 22, 2019 at 6:00 am PT and ending on Thursday, June 20, 2019 at 11:59 pm PT (the “Sweepstakes Period”).

How to Enter: During the Sweepstakes Period, submit a video (30 seconds or less) of some or all of the people you deem to be your family in a favorite vacation spot (the “Video”) or a gif or photo of your family in a favorite vacation spot (the “Photo”). The Photo/Video does not have to be new, and your “vacation spot” can be anywhere you please—from Tahiti to your back yard. You may submit a Photo/Video via social media or by direct submission to Sponsor. To submit a Photo/Video via social media, upload via Facebook, Twitter, or Instagram with the hashtags [#TrueBlueWGNA](#) and [#sweepstakes](#). To submit the Photo/Video directly to Sponsor, send the Photo/Video via email to WGNAmericaPromotions@tribunemedia.com with your name and telephone number. Photo must be in .jpg or .png format. Video must be in .mp4 or .mov format. Gif must be in .gif format. If you enter via Instagram, the “Photos are Private” option in your Instagram account settings must be set to “OFF” so your Instagram profile is public and thus viewable by the Sponsor. If you enter via Twitter, you must have a non-private account. Sponsor is not responsible for Internet connections, unavailability of servers or any other technical malfunctions that may interfere with an entrant’s ability to enter. Limit one entry per person, per email address, and per social media account; subsequent entries from the same person, email address, or social media account will be disqualified if discovered by Sponsor. If there is a dispute over who submitted an entry via social media, the entry will be deemed to have been submitted by the authorized account holder of the social media account used to enter. The authorized account holder of a social media account is deemed to be the natural person who is assigned to the social media account by the social media provider. If there is a dispute over who submitted an entry via email, the entry will be deemed to have been submitted by the authorized account holder of the email account used to enter. The authorized account holder of an email account is deemed to be the natural person who is assigned to an email address by an Internet access provider, service provider, or online organization responsible

for assigning email addresses for the domain associated with the submitted email address. Received email entries (but not the Photos/Videos) become the property of Sponsor and will not be returned. Entries that are incomplete or do not adhere to the Official Rules may be disqualified at the sole discretion of Sponsor.

Other Conditions of Entry: The Video must not contain any music. By entering, each entrant represents and warrants that no laws were broken in the creation of the Photo/Video and that the Photo/Video is his/her own original creation; the entrant owns or otherwise has all rights necessary to submit the Photo/Video; the Photo/Video has not been copied in whole or in part from any other work; the Photo/Video has not been previously published; the Photo/Video does not violate or infringe the rights of any person or entity (including but not limited to privacy rights, trademarks, and copyrights); the Photo/Video does not defame, libel, or slander anyone or any entity; and the Photo/Video does not contain inappropriate, racist, offensive, indecent, vulgar, obscene or profane content. The entrant further represents and warrants that the entrant has the permission of all recognizable individuals in the Photo/Video to submit their image/performance in connection with submission of the Photo/Video in the Sweepstakes. The entrant agrees to confirm that permission by securing releases from all such individuals (and the parent or legal guardian of anyone who is a minor) upon request from the Sponsor. Without limiting the foregoing, the Photo/Video may not show illegal or dangerous activity or nudity or contain any content that, in the sole discretion of Sponsor, is detrimental to Sponsor's brand. The Photo/Video must be appropriate for display on WGN America or on a general interest website. Entries that do not comply with these Official Rules or the foregoing representations and warranties will be disqualified. Each entrant agrees to indemnify, defend and hold Sponsor, its parents, affiliates, and subsidiaries and all of their employees, officers, and directors harmless against any and all liabilities, losses, damages, claims, debts, investigations, fines, penalties, costs, expenses and settlements (including attorneys' fees and costs of litigation, settlement, judgment, interest and penalties) arising out of or related to a breach or alleged breach of the foregoing representations and warranties. By entering, each entrant (regardless of whether entrant wins) grants to the Sponsor a world-wide, perpetual, non-revocable, royalty-free, non-exclusive license (and waives all moral rights in and to the Photo/Video) to publish, display, and distribute his/her Photo/Video as well as derivative works based thereon on WGN America, on the WGN America website and apps, on WGN America social media accounts, and through any and all other media, now known or hereafter devised, in any manner related to the Sweepstakes, without prior notice, approval or compensation. Entrants otherwise will retain all rights to their respective Photos/Videos. If Sponsor determines, in its sole discretion and at any time during the Sweepstakes, that any Photo/Video violates these requirements, is otherwise unsuitable, offensive, or in poor taste, or violates these Official Rules, Sponsor reserves the right to remove and disqualify the Photo/Video. Sponsor retains sole discretion as to whether any Photo/Video satisfies these requirements and the Official Rules. During the Sweepstakes Period, certain Photos/Videos may be selected by Sponsor to be featured in a promotional spot on air. This is not an indication that entrant is a winner or is likely to be a winner. If so, Sponsor may request that entrant sign a release and secure releases from every other recognizable individual in the Photo/Video before the Photo/Video is used.

Winner Selection, Notification, and Verification: After the close of the Sweepstakes Period, Sponsor will select one winner by random drawing from among all eligible entries. The odds of winning depend on the number of eligible entries. Please note, the quality of the Photo/Video will not play a role in the determination of the winner. Sponsor will attempt to notify potential winner via social media or email, and the potential winner must respond within 48 hours of initial notification attempt. Sponsor shall have no liability for winner's failure to receive notices because spam, junk email or other security settings or for winner's provision of incorrect or otherwise non-functioning contact information. If the potential

winner does not respond within 48 hours of initial notification attempt, is ineligible, is not in compliance with the Official Rules, or fails to timely return a completed and executed declaration and release and provide identification as required by the deadline set by Sponsor, the prize may be forfeited and an alternate winner selected by random drawing from remaining eligible entries, time permitting.

Prize: There is one grand prize. The grand prize is a dream family vacation for up to four people, provided in the form of a \$5,000 travel voucher for airfare and lodging from Direct Travel. Voucher subject to terms and conditions thereon. The approximate retail value (“ARV”) of the Grand Prize is \$5,000.
