

**WGN AMERICA**  
**CRIME & WINE SWEEPSTAKES**  
**Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

1. **ELIGIBILITY:** You must be at least 21 years of age or older and a legal resident of the 50 United States or the District of Columbia at the time of entry. The Crime & Wine Sweepstakes (the "Sweepstakes") is not open to employees of Sponsor or those employees' immediate family members. Employees and their immediate family members of any of Sponsor's parents, affiliates, or subsidiaries or of any of the prize providers, advertising agencies, promotional agencies, or other entities involved with the development or administration of this Sweepstakes are also ineligible. For purposes of this Sweepstakes, "immediate family members" means grandparents, parents, siblings, spouse, children (including stepchildren), and in laws. This Sweepstakes is void where prohibited.

2. **TO ENTER:** Sweepstakes begins July 9, 2019 at 7 p.m. PT and runs through August 18, 2019 at 11:59 p.m. PT (the "Sweepstakes Period"). To enter, watch *The Disappearance* (the "Show") on WGN America and look for the code word (the "Code word") displayed on screen during each episode of the Show. The Show airs on Tuesdays from 9 p.m. PT (12 a.m. ET, 11 p.m. CT) through 10 p.m. PT (1 a.m. ET, 12 a.m. CT). Once you have the Code word, log onto [Wgnamerica.com](http://Wgnamerica.com) and follow the Sweepstakes link(s) until reaching the entry page (the "Sweepstakes Page"). Accurately complete the entry form, including the correct Code word, your name, birthdate, and valid email address. All entries must be submitted during the Sweepstakes Period. If any dispute arises as to the identity of any online entrant, the entrant will be considered the individual to whom the entry's email address is assigned, as shown on the email service provider's records. The Code word will be displayed only during each week's premiere presentation of the Show, not during encore presentations.

Entrants must use their own name. Only entries containing the correct Code word will be eligible. Each week during the Sweepstakes Period there will be a new Code word. Entries with a particular Code word must be submitted by 8:59 p.m. PT, 11:59 p.m. ET by the following Tuesday (before the new episode of *The Disappearance* airs). Sponsor reserves the right in its sole discretion to disqualify any entry at any time that in Sponsor's opinion does not comply with these Official Rules. By entering, entrants agree to be bound by and comply with these Official Rules. Limit one entry per person per Code word. Entries containing attachments, generated by a script, macro or other automated means will be disqualified if discovered by Sponsor. Entries in excess of the limit will be disqualified if discovered by Sponsor. Sponsor is not responsible for lost, incomplete, damaged, illegible, late, or misdirected entries, or for errors in mechanical transmission, unavailability of phone lines or connections, cellular phone service, or any other technical malfunctions or inability to transmit messages or entries.

Sponsor reserves the right to delay the announcement of the Code word if breaking news or other unanticipated events prevent the Code word announcement from occurring as scheduled. If such changes occur, they will be posted on the Sweepstakes Page.

3. **WINNER SELECTION, NOTIFICATION, AND VERIFICATION:** After the close of the Sweepstakes Period, Sponsor will select one winner by random drawing from among all eligible entries, subject to verification and compliance with these Official Rules. Odds of winning depend on the number of eligible entries. Sponsor will attempt to notify the winner by email. Winner may be required to execute and return an affidavit of eligibility and release of liability/publicity (TN residents are not required to sign publicity release) prior to receiving their Prize, and, if so, must do so within seven business days of the date Sponsor sends the same to winner. Winner may also be required to provide legally valid proof of identification. The potential winner will be disqualified and Sponsor may select another winner by random drawing from remaining eligible entries (at Sponsor's sole discretion and time permitting) if: (a) winner does not respond within 48 hours of first notification attempt; (b) winner does not fulfill the eligibility requirements; (c) winner does not adhere to these Official Rules; (d) winner does not sign and return any required documents or provide required information by deadlines set by Sponsor; and/or (e) if the prize notification is returned as undeliverable, refused, or declined. Sponsor will conduct up to two alternate drawings for the prize, time permitting.

4. **PRIZE & PRIZE RESTRICTIONS:** One Grand Prize will be awarded. The Grand Prize winner, upon the Sponsor's confirmation of eligibility, will receive a four-day/three-night trip for two people to Sonoma County (the "Location") to visit The Family Coppola's two Sonoma County Wineries ("Grand Prize" or "Prize").

*DAY 4*

*-Winner and Guest fly home*

The Prize package consists of: (a) two round trip standard economy airfare tickets (one for winner and one for travel companion) starting from a major commercial airport in the United States, near the winner's primary residence, as determined by Sponsor (Sponsor reserves the right to substitute ground transportation for air transportation if winner resides within 150 miles of San Francisco, CA); (b) standard (double) hotel accommodations for three nights in the Location (room and tax only); (c) two separate winery tours; (d) \$400 cash stipend for rental car allotment and incidentals. The approximate retail value ("ARV") of the total Prize package is \$4,000, which will vary depending upon points of departure and destination and seasonal fluctuation of hotel rates and airfares. The value of the Prize set forth above represents Sponsor's good faith determinations of the ARV thereof and such determinations are final and binding and cannot be appealed. The Sponsor shall not be liable for any loss or damage to baggage and/or personal property. Travel, hotel and other accommodations are subject to availability. The winner and guest must travel on same itinerary. Travel must be completed by December 31, 2019 or the Prize will be forfeited. All travel dates are subject to change in the Sponsor's sole discretion. Prize is nontransferable, except at Sponsor's sole discretion. Prize details and availability are subject to change, in which case Sponsor may substitute a Prize of equal or greater value. No substitutions or cash redemptions, except at

By entering, entrants agree to release, indemnify and hold harmless Sponsor, Twitter, Facebook, Prize providers, and their parent companies and affiliates, and the advertising agencies, promotion agencies, and other entities involved with the development or administration of this Sweepstakes and each of their employees, officers, and representatives, from any and all liability, loss, damage, costs or claims related to any allegation regarding participation in the Sweepstakes and/or the award of, the receipt of, or the use of their Prize.

Some jurisdictions do not allow for limitations on the ability to pursue class action remedies, or certain kinds of damages, and so these limitations may not apply to you. Sponsor assumes no liability for (a) any incorrect or inaccurate entry information; or (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes. If a dispute arises regarding compliance with these Official Rules, Sponsor may consider, in its sole discretion, data reasonably available to Sponsor through information technology systems in Sponsor's control, but Sponsor will not be obligated to consider any data or other information collected from any other source. If there is any conflict between any term of these Official Rules and any advertising or entry materials used in connection with the Sweepstakes, the terms of these Official Rules will govern. Neither the failure of Sponsor to insist upon or enforce strict performance of any provision of these Official Rules or the failure, delay or omission by Sponsor in exercising any right with respect to any term of these Official Rules, will be construed as a waiver or relinquishment to any extent of Sponsor's right to assert or rely upon any such provision or right in that or any other instance.

6. **DISRUPTION:** If for any reason, this Sweepstakes is not capable of running as planned, including infection by computer virus, tampering, fraud, technical failure, or any other cause that corrupts or threatens the administration, security or integrity of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to terminate or suspend the Sweepstakes or any portion of the Sweepstakes. If Sponsor terminates the Sweepstakes, it will determine the winner by random drawing from among all eligible, non-suspect entries received prior to the termination, provided Sponsor is able to do so. If Sponsor terminates or modifies the Sweepstakes, Sponsor will post notice on the official Sweepstakes website and on the next airing of the Show.

7. **NO AFFILIATION WITH FACEBOOK OR TWITTER:** This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook or Twitter. Any questions, comments or complaints regarding the Sweepstakes should be directed to Sponsor, not Facebook or Twitter.
