LAST MAN STANDING BAXTER'S BACK TO SCHOOL SWEEPSTAKES
Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **SWEEPSTAKES DATES:** The *Last Man Standing* Back to School Sweepstakes (the "Sweepstakes") will begin August 15, 2019 at 4:00 PM PT and runs through August 16, 2019 at midnight PT (the "Promotion Period"). The Sweepstakes will be held in connection with the display of *Last Man Standing* (the "Show") on WGN America. The Show will air on Thursday and Friday, August 15 and 16, from 7 PM ET to midnight ET and from 7 PM PT to midnight PT. During each hour of the Show a different code word (the "Code Word") will be displayed for a total of five Code Words per day.

2. **ELIGIBILITY:** You must be at least 18 years of age or the age of majority in your state of residence, whichever is older, and a legal resident of the 50 United States or the District of Columbia at the time of entry. The Sweepstakes are not open to employees of Sponsor or those employees' immediate family members. Employees and their immediate family members of any of Sponsor's affiliated companies, licensees, advertising or promotional agencies, or sponsors are also ineligible. For purposes of these Sweepstakes, "immediate family members" means grandparents, parents, siblings, spouse, children (including stepchildren), and in laws. These Sweepstakes are void where prohibited.

3. **TO ENTER:** To enter, watch the Show on WGN America and look for the code word (the "Code Word") displayed on screen during each hour the Show airs. Once you have the Code Word, log onto Wgnamerica.com and follow the Sweepstakes link(s) until reaching the entry page (the "Sweepstakes Page"). Accurately complete the entry form, including the correct Code Word, your name, birthdate, and valid email address. You may also submit an optional mobile telephone number if you wish to receive winner notification by text. Entries for each Code Word must be submitted by no later than the end of the hour in which the Code Word is released. If you provide a mobile telephone number, you must have a valid mobile telephone number and text messaging two-way capable handset. Message and data rates may apply. Text messaging and wireless services are not available in all areas. Text STOP to stop and HELP for help. If any dispute arises as to the identity of any entrant, the entrant will be considered the individual to whom the entry's email address is assigned, as shown on the email service provider's records.

Entries containing attachments, generated by a script, macro or other automated means will be disqualified. Entrants must use their own name. Only entries containing the correct Code Word will be eligible. Sponsor reserves the right in its sole discretion to disqualify any entry at any time that in Sponsor's opinion does not comply with these Official Rules. By entering, entrants agree to be bound by and comply with these Official Rules. Limit one entry per person, per

Code Word. Entries in excess of the limit will be disqualified if discovered by Sponsor. Sponsor is not responsible for lost, incomplete, damaged, illegible, late, or misdirected entries, or for errors in mechanical transmission, unavailability of phone lines or connections, cellular phone service, or any other technical malfunctions or inability to transmit messages or entries.

Sponsor reserves the right to delay the announcement of the Code Word if breaking news or other unanticipated events prevent the Code Word announcement from occurring as scheduled. If such changes occur, they will be posted on the Sweepstakes Page.

4. **SELECTION OF WINNERS:** After the close of the Promotion Period, Sponsor will select one grand prize winner and five runner-up prize winners by random drawing from among all eligible entries, subject to verification and compliance with these Official Rules. Odds of winning depend on the number of eligible entries. Sponsor will announce potential winners on social media and on the Sweepstakes Page and will attempt to notify the winners by email. A potential winner will be disqualified and Sponsor may select another winner by random drawing from remaining eligible entries for that Sweepstakes (at Sponsor's sole discretion and time permitting) if: (a) potential winner does not respond within 48 hours of first notification attempt; (b) potential winner does not fulfill the eligibility requirements; (c) winner does not adhere to the Official Rules; (d) potential winner does not sign and return any required documents or provide required information by deadlines set by Sponsor; and/or (e) if the prize notification is returned as undeliverable, refused, or declined. Sponsor will conduct up to two alternate drawings for each prize, time permitting.

5. **PRIZES & PRIZE RESTRICTIONS:** There is one grand prize, and there are five runner-up prizes. The grand prize is an Apple computer awarded in the form of a \$1,500 Apple gift card. Each runner-up prize is a \$200 Amazon gift card to be used for school supplies. Gift cards subject to terms and conditions thereon. Each prize is nontransferable, except at Sponsor's sole discretion. Prize details and availability are subject to change, in which case Sponsor may substitute a prize of equal or greater value. No substitutions or cash redemptions, except at Sponsor's sole discretion. All properly claimed prizes will be awarded provided a sufficient number of eligible entries are received, but in no event will Sponsor award more prizes than are provided for in these Official Rules.

6. **CONDITIONS & RESTRICTIONS:** Entrants agree Sponsor has the sole right to decide all matters and disputes arising from these Sweepstakes and that its decision is final and binding. Except where prohibited by law, entrants agree to allow use of their name, voice, photograph, likeness, and hometown, in any medium of communication, including print, Internet, radio and/or television and for any purpose in connection with the Sweepstakes, including advertising, promotional or other purposes, by Sponsor and/or its affiliates, without additional compensation. By entering, entrants agree to release, indemnify and hold harmless Sponsor, Twitter, Facebook, prize provider and their parent companies and affiliates, and each of their employees, representatives, contractors, sponsors and advertisers, from any and all liability, loss, damage, costs or claims related to any allegation regarding participation in the Sweepstakes and/or the award of, the receipt of, or the use of their prize. Winner may be

required to execute and return an affidavit of eligibility and release of liability/publicity (TN residents are not required to sign publicity release) prior to receiving their prize, and, if so, must do so within seven business days of the date Sponsor sends the same to winner.

As a condition of entering, entrants agree: (a) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental, consequential, or any other damages, other than for actual out-of-pocket expenses; (b) all causes of action arising out of or related to the Sweepstakes, or prizes awarded, will be resolved individually, without resort to any form of class action, and exclusively by the appropriate court in Cook County, Illinois, to which participant submits to personal jurisdiction; and (c) any and all claims, judgments, and awards will be limited to actual out-of-pocket costs incurred, excluding attorneys' fees and court costs. Some jurisdictions do not allow for limitations on the ability to pursue class action remedies, or certain kinds of damages, and so these limitations may not apply to you. This Sweepstakes will be governed and enforced pursuant to Illinois law, excluding choice of law provisions.

Sponsor reserves the right to prohibit any entrant from participating in the Sweepstakes if, at its sole discretion, Sponsor finds such entrant to be tampering with the entry process or the operation of the Sweepstakes, or if such entrant shows a disregard for, or attempts to circumvent, these Official Rules, or acts: (a) in a manner the Sponsor determines to be not fair or equitable; (b) in an annoying, threatening, or harassing manner; or (c) in any other disruptive manner. Sponsor assumes no liability for (a) any incorrect or inaccurate entry information; or (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of any of these Sweepstakes. If a dispute arises regarding compliance with these Official Rules, Sponsor may consider, in its sole discretion, data reasonably available to Sponsor through information technology systems in Sponsor's control, but Sponsor shall not be obligated to consider any data or other information collected from any other source. If there is any conflict between any term of these Official Rules and any advertising or entry materials used in connection with the Sweepstakes, the terms of these Official Rules will govern. Neither the failure of Sponsor to insist upon or enforce strict performance of any provision of these Official Rules or the failure, delay or omission by Sponsor in exercising any right with respect to any term of these Official Rules, will be construed as a waiver or relinquishment to any extent of Sponsor's right to assert or rely upon any such provision or right in that or any other instance.

If Sponsor terminates the Sweepstakes, it will determine the winners by random drawing from among all eligible, non-suspect entries received at the time of the termination, provided Sponsor is able to do so, and Sponsor will not release subsequent Code Words. If Sponsor terminates or modifies any of the Sweepstakes, Sponsor will post notice on the official Sweepstakes website and on the next showing of the Show.
